

## TERMS AND CONDITIONS

Benefits apply only for Guest(s) with a reservation at a Vidanta Resort (hereafter the “Resort”) through Resorts Condominiums Internacional de México, S. de R.L. de C.V. Benefits are non-transferrable, non-cumulative with other benefits, promotions, discounts and/or certificates; none of the benefits shall be redeemable for cash or other goods.

### 1. RESORT FEE:

The cost of the Resort Fee is dependent on the destination and the type of unit reserved. It is a rate per stay per reservation. Resort fee amounts are listed below.

For Nuevo Vallarta and Los Cabos:

- The mandatory resort fee per hotel unit (Master Room), per stay is \$250.00 (Two hundred and fifty U.S. dollars\*).
- The mandatory resort fee per one bedroom Suite (1B), per stay is \$400.00 (Four hundred U.S. dollars\*).
- The mandatory resort fee per two-bedroom Suite or any larger unit (2B or more), per stay is \$550.00 (Five hundred and fifty U.S. dollars\*).

For Riviera Maya, Puerto Vallarta, Puerto Peñasco, Acapulco and Mazatlán:

- The mandatory resort fee per hotel unit (Master Room), per stay is \$150.00 (One hundred and fifty U.S. dollars\*).
- The mandatory resort fee per one bedroom Suite (1B), per stay is \$300.00 (Three hundred U.S. dollars\*).
- The mandatory resort fee per two-bedroom Suite or any larger unit (2B or more), per stay is \$450.00 (Four hundred and fifty U.S. dollars\*).

*\*Amounts are established in US Dollars (legal currency in the United States of America). Amount may be paid in Mexican pesos according to the exchange rate published by the Mexican National Bank (Banxico) at the Diario Oficial de la Federación, in the date of payment of the resort fee.*

### 2. WELCOME COCKTAIL:

One complimentary welcome cocktail per person registered to the unit booked, given at check-in. Non-alcoholic beverages are available for minors.

### 3. GYM ACCESS:

The primary guest and their companion(s) (registered at the unit) may have access to the Gym facilities located at the Resort. Gym facilities vary upon the different Resort brands.

### 4. HOUSEKEEPING SERVICES:

Daily basic room housekeeping service during the stay. Kitchen cleaning does not apply.

### 5. INTERNAL RESORT TRANSPORTATION<sup>1</sup>:

The Internal transportation at the Resort consists in established short and schedules routes among the different areas at the Resort in special transportation vehicles.

### 6. VIDANTA GOLF COURSE TRANSPORTATION<sup>2</sup>:

The transportation service to the Vidanta Golf Course consists in round trip from the Resort to the Vidanta Golf Course and back from Vidanta Golf Course to the Resort through special vehicles in pre-established and scheduled routes.

### 8. ACCESS TO EXCLUSIVE WORLD-CLASS ENTERTAINMENT EXPERIENCES<sup>4</sup>:

Primary guest and their companion(s) will receive access to Santuario, an indoor-outdoor entertainment pavilion which offers a nightly lineup of acts.

**9. ADDITIONAL SERVICES:**

The following additional services will be available for the primary guest and their companion(s):

**10. CHARGES NOT INCLUDED IN THE RESORT FEE:**

The amount established as Resort Fee does not include the payment of the following taxes: Lodging Tax (“*Impuesto Sobre Hospedaje ISH*”) at any of the Vidanta Resorts; and in the case of the Vidanta Riviera Maya Resort the Environmental Sanitation Right (“*Derecho de Saneamiento Ambiental*” *DEERSAN*) tax. Payment of the taxes, as well as all charges for additional services contracted during your stay at the Resort must be settled at the time of check-out.
